# **Entity Information**

The name of the filing entity is ST. REWEIS COPTIC ORTHODOX CHURCH, INC. a Florida nonprofit corporation formed on November 18, 2009, and whose document number issued by Florida Division of Corporation is N09000011142.

#### Amendment

The following amendments to the Articles of Incorporation were adopted by a majority vote of the board of directors:

Amend Article VIII and Article IX to read as follows:

#### ARTICLE VIII

The Coptic Orthodox Church defines marriage as one of the seven Mysteries (Sacraments) of the Church, officiated by a consecrated Coptic Orthodox bishop, priest, or both (or other Orthodox bishop, priest, or both, who is/are in full communion with the Coptic Orthodox Church), in good standing, uniting one man and one woman. The Coptic Orthodox Church defines a man as a human being having the reproductive sexual organs of a male from birth, and the Coptic Orthodox Church defines a woman as a human being having the reproductive sexual organs of a female from birth.

## ARTICLE IX

The Coptic Orthodox Church shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Orthodox Church of Alexandria adopted by the Holy Synod of the Coptic Orthodox Church as well as the Synodical Committee for the Coptic Orthodox Churches in the land of Immigration..
