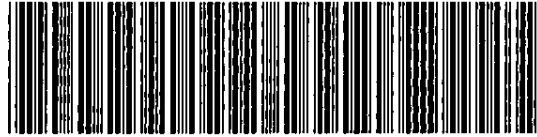

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is established to provide an afterschool enrichment and tutoring program for children in grades 1 through 8. It will also work to teach children new skills and help them identify and strengthen skills that they possess. In addition, the Center will teach children about good nutrition and the benefits of physical exercise. The Center will provide a bridge between school and parents where children can learn in a nurturing, healthy and safe environment which empowers them with the knowledge and skills that leads to life success.
The Corporation is organized exclusively for charitable and education purposes, including for such purposes, the making of distributions to organizations that qualify under section 501(c3) of the Internal Revenue Code or any corresponding section of any future federal tax code.
No proceeds from the corporation will enrich any individual except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax exempt, charitable organization under the provisions of 501(c3) of the Internal Revenue Code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

There will be a minimum of 3 board members but not more than 8. The initial Board of Directors will be appointed by the Incorporator of the Empowered Youth Afterschool Center, Inc. Subsequent Directors will be elected by a majority vote of the current Board. The initial Board will serve for one year unless elected to a concurrent term.
