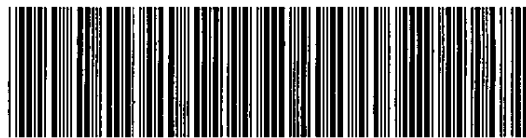

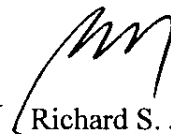

**ARTICLES OF INCORPORATION
OF
ARBOR LAKE HOMEOWNERS' ASSOCIATION OF CRESTVIEW, INC.**

The undersigned, acting as incorporator of a not-for-profit corporation organized pursuant to Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

EFFECTIVE DATE 11/17/09

ARTICLE I. CORPORATE NAME

The name of this corporation shall be ARBOR LAKE HOMEOWNERS' ASSOCIATION OF CRESTVIEW, INC.

ARTICLE II. PRINCIPAL OFFICE

The initial principal place of business of this corporation is 107 N. Partin Drive, Niceville, FL 32578; and the mailing address is 107 N. Partin Drive, Niceville, FL 32578.

ARTICLE III. NATURE OF BUSINESS

This corporation shall be a not-for-profit corporation in accordance with Chapter 617, Florida Statutes, the primary purpose for which will be to own the common areas designated on the following described real property, to wit:

Arbor Lake is a proposed subdivision to be recorded in the Public Records of Okaloosa County, Florida, and to provide for the improvement, maintenance, landscaping and deal with other matters relating to the common areas shown on said plat; to affix, levy and collect all charges and assessments made against any lot in Arbor Lake or any other property coming under the jurisdiction or authority of this corporation, as provided by the Declarations of Covenants, Conditions, and Restrictions relating thereto as recorded in the Public Records of Okaloosa County, Florida and pursuant to such bylaws as may be established for this corporation; and to otherwise deal to the full extent permitted by law, with any matters relating to the management or control of any property coming under the authority of this corporation.

ARTICLE IV. MANNER OF ELECTION

Nominations shall be submitted for consideration in writing at least 60 days prior to the annual meeting at which elections are held. All nominations shall be subject to the Florida Administration Code. Election to the board of directors shall be by secret written ballot. At such elections the members or their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of these Articles. The persons receiving the largest number of votes shall be elected. Elections shall be conducted according to Florida Administrative Code.

ARTICLE V. DIRECTORS

This corporation shall have no less than three directors at any time. The names and street addresses of the initial members of the Board of Directors are:

ARTICLE VI. INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered agent office of this corporation shall be located at 107 N. Partin Drive, Niceville, Florida 32578, and the name of the initial registered agent is Richard Johnson.

ARTICLE VII. INCORPORATORS

The name and street address of the incorporator of these articles of incorporation is: Richard S. Johnson, 107 N. Partin Drive, Niceville, Florida 32578.

ARTICLE VIII. TERM OF EXISTENCE

This corporation is to exist perpetually.

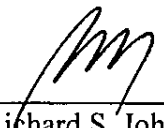
ARTICLE IX. AMENDMENTS

ARTICLE X. EFFECTIVE DATE

These Articles of Incorporation shall be effective the 17th day of November, 2009.
