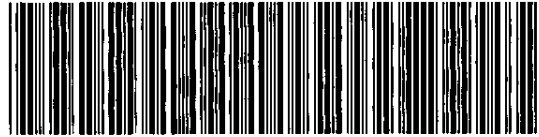

In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Parsons Circle Outreach Inc, is a PUBLIC BENEFIT nonprofit corporation that is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 ( c )(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Specifically, this nonprofit corporation is organized and operated to provide recreational, educational, and supportive social services to senior citizens, economically disadvantaged, unemployed and underemployed community residents of Central Florida by providing direct services such as job training, adult daycare, counseling, youth mentorship programs, and food bank services. In addition informational and referral services will be provided to link community residents to existing health, educational and social services with the goal of diminishing high rates of unemployment, crime, illiteracy and poor access to health care.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501 ( c )(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.
