**ARTICLES OF INCORPORATION  
OF

(A Florida Not-For-Profit Corporation)**

THE UNDERSIGNED with the intent to form a Florida not-for-profit corporation under Chapter 617 Florida Statutes does hereby execute these Articles of Incorporation and states:

1. **Name:** The name of the corporation shall be CENTER POINTE FELLOWSHIP, INC.
2. **Principal Office:** The principal street address and mailing address of the corporation is 1275 Gateway Blvd., Boynton Beach, Florida 33426-8302.
3. **Purpose:** The purpose of this corporation is to operate as a church. It is intended that this organization qualify as a church and as a religious organization in accordance with the provisions of Section 501(c)(3), 170(b)(1)(A)(i), 2055(a)(2), and 2522(a)(2) of the Internal Revenue Code and its valid regulations; and it shall be operated and governed in all regards in accordance with this intent.

5. **Manner of Election of Board of Directors:** The number of Directors of the corporation may be increased or decreased (but not below three directors), vacancies in the Board of Directors may be filled, and qualifications and terms of service may be established by a unanimous vote of the Directors then serving.

The powers, duties, and responsibilities of the officers of the corporation may be determined by the by-laws of the corporation. However, the duties of the Assistant Secretary of the corporation shall be limited solely to the execution or attestation of such corporate documents as is authorized by the President, the Board of Directors, or other authorized officer of the corporation.

7. **Statement of Faith, Church Constitution, and By-Laws:** Subsequent to incorporation the Directors shall meet to organize the corporation and adopt a statement of faith, church constitution, and by-laws governing the corporation, which instruments shall be adopted by a unanimous vote of the Directors. Such instruments may be modified from time to time by a unanimous vote of the Directors or as otherwise provided in the church by-laws. Any such document shall be in full compliance with the corporate purposes described in Section 3 above.
