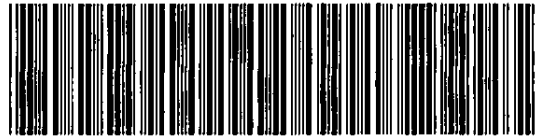

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation:

**ARTICLE ONE**  
**NAME**

The name of the corporation is Tivoli Historical Society, Inc.

**ARTICLE TWO**  
**PRINCIPAL OFFICE**

The street address of the initial principal office of the corporation is 202 Knoxhill Road, Ponce De Leon, Florida 32455. The mailing address is Post Office Box 1598, DeFuniak Springs, Florida 32435.

**ARTICLE THREE**  
**PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

1. To ensure the availability of educational experiences to enable "at risk" students to attain/maintain levels of achievement mandated by state requirements.
2. To further student progress by tutoring, mentoring, facilitating study groups, and supervised homework sessions.
3. To make available educational and enrichment experiences that benefit community residents of all ages.
4. To offer experiences that expose students to a variety of cultural experiences to increase interest, self esteem, and self modification.
5. To collect, preserve, and exhibit the history of Walton County Schools for students past and present within the community.
6. To utilize community resources to enhance the quality of education for students within the community.

7. To procure financial assistance, program funds, grants, and conduct fund raisers and other financial resources to enhance and support organizational objectives.
8. To protect and preserve the historical contribution within the community for the Tivoli Historical Society.

#### **ARTICLE FOUR DIRECTORS**

The number of directors constituting the corporation's initial board of directors shall be eight (8). The names and addresses of each person who is to serve as a member of the initial board of directors are:


