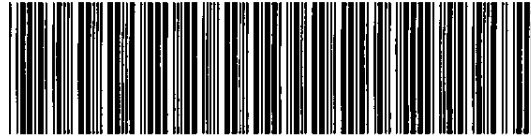

Pursuant to the provisions of section 617.1006, Florida Statutes, The undersigned Florida non-profit corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE III CHANGED TO READ:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific Purpose(s) are: The History of Great Christian Preachers & Ministries Center is to collect, preserve, and interpret objects related to the various Ministries and Preachers such as pictures, videos, audio, and any paper documentation pertaining to the aforementioned. We want people from all over the world no matter their ethnicity and or religious preference to have a place where they can view, read and hear about all the great Christian ministries.

ARTICLE XII CHANGED TO READ:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

On motion and by unanimous vote by the board of directors, the preceding articles of amendment of History of Great Christian Preachers & Ministries Center, Inc. were adopted. There are no members or members entitled to vote on the amendments.
