**Articles of Incorporation (Continued)**  
**Gospel for Nations Ministry, Inc**  
**A Nonprofit Corporation**

**Dissolution provision**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Duration of Corporation**

The period of duration of this corporation is perpetual.

**Additional Provisions**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**Gospel for Nations Ministry, Inc.**  
**A Nonprofit Corporation**

**PURPOSE FOR WHICH THE NONPROFIT CORPORATION IS ORGANIZED:**

"The Gospel for Nations Ministry, Inc is a Christian non-profit organization. The organization's aim is to spread the Gospel, by providing spiritual, psychological, and material services both domestically and internationally to all people in need, especially orphans and needy families overseas; by training and supporting missionaries overseas, producing religious video and audio, and building churches".

"This organization (corporation) is organized exclusively for charitable, religious, educational, and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said code section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code."

"No part of the net earnings of the organization (corporation) shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof."

"No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as provided in section 501(h) of the Internal Revenue Code, and the organization shall not participate in, or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office."

"Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code."

"Upon the dissolution and winding up of the organization (corporation), after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code and which has established its tax-exempt status under that section or corresponding section of any future federal tax code; or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, to such organization or organizations as said Court shall determine, and which are organized and operated exclusively for such purposes."

"The making of grants and contributions and otherwise rendering financial assistance to section 170(c)(2) organization shall be within the exclusive power of your board of directors."

"In furtherance of Gospel for Nations Ministry, Inc exempt purpose(s), the board of directors has the power to make grants to any organization organized and operated exclusively within the meaning of section 501(c)(3) and described section 170(c)(2) of the Code as opposed to restricting grants to a specified foreign organization(s).

"The board of directors will review all requests for funds from other organizations, will require that such requests specify the use in which the funds will be put, and if the board of directors approves the request, will authorized payment of such funds to the approved grantee for those specified projects(s) only."

"In such case that the grantee be in foreign country, the board will determine that it is organized and operated to meet all requirements of section 170(c)(2) of the Code excepting the requirement set forth in section 170(c)(2)(A)."

"The foreign charity/recipient must agree to submit periodic accounting of the funds it has received, and the domestic charity must require periodic reports of the funds, to ensure that the funds are being used for its intended purposes(s). The foreign charity/recipient must further agree that any donated funds not spent must be returned to Gospel for Nations Ministry, Inc."
