Pursuant to s. 617.0901, Florida Statutes, this certificate of reincorporation was duly authorized by a meeting of its members regularly called or by a meeting of its board of directors if there were no members entitled to vote on the reincorporation:

The specific purpose for which the corporation is organized:

This is a fundamental gospel organization whose purpose is to promote the salvation of souls and to preserve our inalienable right to worship God.

ARTICLE IV MANNER OF ELECTION

Directors shall be elected annually by a one vote majority of members in regular session for such business.

CHARTER OF

THE GOOD SAMARITAN CHURCH, INCORPORATED

1. The name of this corporation is to be "THE GOOD SAMARITAN CHURCH INCORPORATED" with its principal place located adjacent to the City of Jacksonville, County of Duval, State of Florida.
2. The term for which it is organized shall be perpetual.
3. The general nature and purpose of this corporation being a fundamental gospel organization to promote the salvation of souls through the blood atonement of Jesus Christ and to permit any individual the right to affiliate and become a member of said organization by acknowledging Jesus Christ as their Savior. To further establish a living memorial to all those who have made the supreme sacrifice to preserve our inalienable right to worship God according to the dictates of our own conscience, Honorable mention being made of OTIS L. BROWN and OSCAR LAVERNE OLSON.
4. To accomplish these objects, and for that purpose only, this corporation shall have power:
 - (a) To buy, own, lease, mortgage, sell, convey, or otherwise dispose of real and personal property of any character whatsoever in the State of Florida or elsewhere, incidental to its said purposes.
 - (b) To accept or receive property or credit by gift, devise or bequest; to borrow money and to accept and execute necessary evidence of indebtedness therefor; to perform services and enter into contract therefor under the terms of which it may accept compensation.
 - (c) To license and ordain Ministers and Preachers of the Gospel, and to elect and ordain Deacons of the Church.

5. The corporation shall have the right in its discretion to provide for and to pay persons rendering special services; such compensation shall be appropriate to the value of such services and no one shall be disqualified to receive such compensation by reason of the fact that he or she is a member, officer, director of the corporation or an employee or agent thereof.
6. In general to carry on any lawful operation in connection with the foregoing and to have and exercise all the powers conferred by the State of Florida upon corporations under the laws of Florida and to do any and all of the things herein set forth to the same extent that natural persons might or lawfully could do.
7. The private property of the members, officers, directors and all incorporators shall not be subject to the payment of the corporation's debts to any extent whatsoever.
8. The corporation shall not have any capital stock nor shall it be conducted for profit and the membership therein shall be confined to those persons who have acknowledged Jesus Christ as their Savior and who will diligently seek to advance the teachings and doctrines of christianity.
9. The corporation reserves the right to amend, alter, change or repeal any provision contained in this certificate of incorporation in the manner now or

hereafter prescribed by statute and all rights conferred upon members, the officers and Board of Directors of the corporation herein are granted subject to this reservation.

10. In the event of any litigation, dissolution or winding up the affairs of the corporation, whether voluntary or involuntary, except for the purpose of reorganization, the assets of the corporation, after all debts and liabilities are paid, shall be turned over to the government of the State of Florida through its Treasury and to its general fund for such use as it may deem proper or as may be provided under the laws of the State of Florida.

12. The officers of this corporation shall be a President, Vice-President, Secretary, and Treasurer; whom shall be elected by a one vote majority of the members. All official papers and documents of the Corporation shall be signed by the President and attested by the Secretary. Seven persons who are members of the corporation shall comprise and constitute the Board of Directors; the Directors shall be elected annually by a one vote majority of members in regular session for such business and shall be only removable therefrom for cause by vote of

two-thirds of members in special called meeting.

Those Directors who shall manage or control the corporation, for the first term or part of term, shall be as follows:

1. Director of Church (Pastor, and President of corporation)

2. Director of Education (and Vice President of corporation)
Frank Bouris, Sr., RFD 2, Jacksonville, Fla.
3. Director of Music,

Sally Mae Kerna, RFD 2, Jacksonville, Fla.
5. Director of Social Activities,
Leola Virginia Phillips, RFD 2, Jacksonville, Fla.
6. Director of Finance (and Treasurer of corporation)
Ernest Amos Newman, RFD 2, Jacksonville, Fla.
7. Director of Church Records (and Secretary of corporation)
Annie Mae Jones, RFD 2, Jacksonville, Fla.

The duties of each office as set forth numerically above shall be perpetual.

13. The by-laws of this corporation are to be made, altered, amended or rescinded by the membership.
14. The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall be never greater than two-thirds of the value of the property of the corporation.
14. The amount and value of the real estate which the corporation may hold, subject always to the approval of one of the Circuit Judges of the State of Florida, shall be unlimited.

incorporators hereinbefore named, for the purpose of
forming a corporation not for profit, hereby declare
and certify that the facts herein stated are true,
and accordingly have hereunto set our hands and seals,
this 12th day of January A.D. 1946.
