

**ARTICLES OF INCORPORATION
OF**

PALM BEACH COUNTY FIRE RESCUE EXPLORER POST 205, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a non-profit business corporation.

ARTICLE I- NAME

The name of the Corporation is: PALM BEACH COUNTY FIRE RESCUE EXPLORER POST 205, INC.

ARTICLE II- EFFECTIVE DATE

The existence of the Corporation shall begin on: the date that these Articles of Incorporation are filed with the Secretary of State.

ARTICLE III- PRINCIPAL OFFICE

The principal place of business and the mailing address of the principal office of the Corporation is: 405 Pike Road, West Palm Beach, Florida 33411.

ARTICLE IV- INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial street address of the Corporation's registered office is: 405 Pike Road, West Palm Beach, Florida 33411.

The initial registered agent for the Corporation at that address is: Judy A. Ruddy.

ARTICLE V- PURPOSE

The purpose for which the Corporation is organized is exclusively for charitable and educational purposes, under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The purpose for which the Corporation is specifically organized is to educate and provide young adults from 14 to 20 years of age the opportunity to learn from and shadow professional fire fighters while they perform the duties of their job. The Corporation shall further provide instruction to the same youth in the areas of CPR and First Aid.

The general nature of business to be transacted by the Corporation shall be any or all lawful business which non-profit corporations incorporated under Chapter 617 of the Florida Statutes may

transact that are in furtherance of the educational and charitable purposes of this Corporation and further to engage in any lawful act, activity or business permitted under the laws of the United States of America and of the State of Florida that are in furtherance of the educational and charitable purposes of this Corporation.

Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

ARTICLE VI- INITIAL DIRECTORS

The initial board of directors shall consist of three (3) members. This number may be increased from time to time in accordance with the Corporation's Bylaws, but shall never be less than three (3). The name and address of the persons who will serve on the initial board of directors are:

The Corporation shall indemnify its directors, officers, and agents to the fullest extent permitted by law.

ARTICLE IX- NO DISTRIBUTION OF EARNINGS


to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV herein.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.


ARTICLE X- DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Fifteenth Judicial Circuit Court in and for Palm Beach County, Florida in which the principal office of the organization is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




