The undersigned are hereby associated for the purpose of becoming a corporation not-for-profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation not-for-profit.

ARTICLE I - NAME

The name of this corporation is **FIRST BAPTIST PRE-SCHOOL OF LABELLE, INC.**, a corporation not-for-profit, located at 330 North Main Street, LaBelle, Florida 33935.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

The general purpose of the corporation is to conduct a pre-school program for the children of LaBelle and surrounding communities.

ARTICLE IV - VOTING RIGHTS

Each member is entitled to one vote at Corporation membership meetings.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI - INCORPORATOR

ARTICLE IX - AMENDMENT OF BYLAWS

Any amendments to the bylaws of this corporation may be made at any regular or special meeting of the members by a notice of such amendment, stating the proposed change, shall have been give to those members at least ten (10) days prior to such meeting.

ARTICLE X - AMENDMENT OF ARTICLES

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the members is subject to this reservation. Amendments may be made at any regular or special business meeting of the members by a majority vote of those members present and voting, providing notice of such amendment stating the proposed change shall have been given to the members at least ten (10) days prior to such meeting.

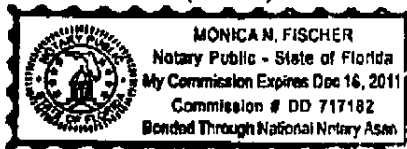
