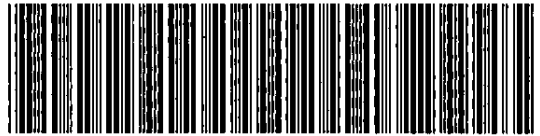



ARTICLE III- PURPOSE

1.
