

**ARTICLES OF INCORPORATION  
OF  
DOBIE-RESCUE NORTH FLORIDA, INC.**

**ARTICLE I - NAME**

The name of the Corporation shall be Dobie-Rescue North Florida, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE III - PURPOSE**

The primary purpose of this organization is to rescue Doberman Pinschers that are abused, neglected, or abandoned and to successfully re-home them.

- (a) This organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under sections 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (b) No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- (c) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

A majority of the total number of directors present at any meeting shall constitute a quorum for the transaction of corporate business.

In the event of a vacancy on the Board of Directors by resignation, death, or removal, the successor shall be elected by a majority vote of the remaining directors.
