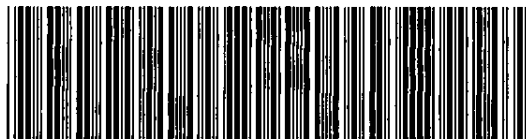





ARTICLE III:

SAID CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, SCIENTIFIC AND EDUCATIONAL PURPOSES PERTAINING TO SPIRITUAL SUPPORT AND SERVICES FOR CATHOLICS WHO CANNOT ATTEND MASS WHILE TRAVELLING OR OTHER REASONS, INCLUDING FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE (OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE).

ARTICLE VIII:
