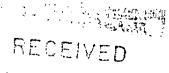

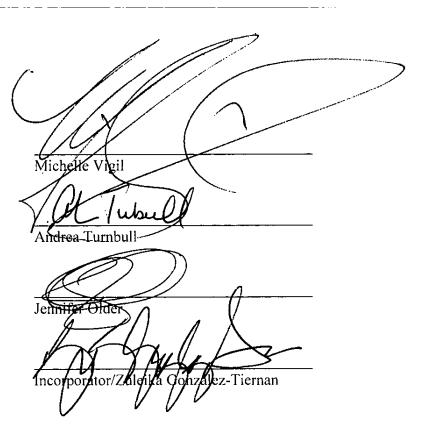
Article X – Amendment to Articles of Incorporation
