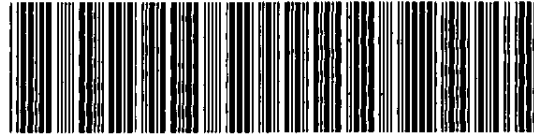

**ARTICLE I**

The name of this Non Profit Corporation is:

**ARTICLE IV**

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To foster, support, and engage in activities relative to the Well being of mankind, sustainable socioeconomic development, appropriated technology, progress and ideas, including any and all activities, which are lawful and appropriate in accordance with the laws of the State of Florida and the Dominican Republic. The organization shall engage in activities and programs that serve the Dominican communities in the United States and Dominican Republic, and which serve to promote environmental safety, cultural and human development, mutual understanding, and public service in both countries.

To engage in any activity permitted under the laws of the laws of the United State of America, its territories, districts, and possessions, and any activity permitted under the Laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by chapter 617, Florida Statutes

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things ,incidental or appurtenant to or growing out of or connected with the aforesaid business of powers,

or any part thereof; provided, that the same be not inconsistent with the laws under which this corporation is organized.

The purposes for which **FOUNDATION ING. WAGNER JOSE, INC** is organized are exclusively charitable, scientific, literary and educational purposes, including , for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of section 501©(3) of the Internal Revenue Code of 1986 or the organization shall establish the following objectives:

- 1) To research alternative ways and means to upgrade Foundation Ing. Wagner Jose.
- 2) To seek funds to help the poor and needed people in Dominican Republic;
- 3) To assist local communities in enhancing their socio-ecological status, and
- 4) To work in cooperation with the central and local governments to implement a plan to help the most needed people in Dominican republic

#### **Article V**

No part of the net earning of the organization shall inure to the benefit of, or be distributable to its member, trustees, officer, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene (Including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carries on (a) by an organization exempt from federal income tax under section 501 © (3) of the Internal Revenue code or corresponding section of any future federal tax code, or (b) by an organization contributions to which are deductible under section 170© (2) of the Internal Revenue code or corresponding section of any future federal tax code.

Annually, during the month of December, the membership shall elect, from among those nominees previously approved by the **Executive Committee** of the board, those members receiving the highest number of votes as there are vacancies

Annually, during the month of December, the membership shall elect, from among those nominees previously approved by the **Executive committee** of the board, those members receiving the highest number of vote as there are vacancies. Each elected be Re-elected for an additional three (3) year term.

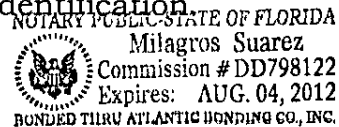

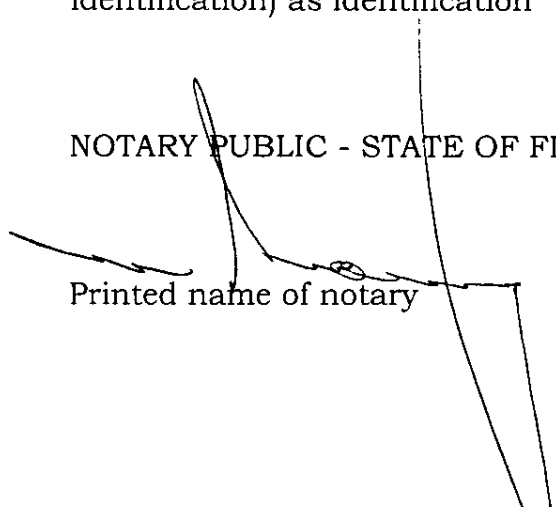
