The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

## ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be CRESCITA, A NOT FOR PROFIT AGENCY, INC.

#### ARTICLE II - PERIOD OF DURATION

These Articles of Incorporation shall be effective December 14, 2009, and the period of duration of the Company shall be perpetual, commencing upon execution of the Articles of Organization.

## ARTICLE III - ADDRESS OF PRINCIPAL OFFICE AND MAILING ADDRESS OF CORPORATION
