#### ARTICLES OF INCORPORATION

(A Not For Profit Corporation)

### **ARTICLE 1**

#### **NAME**

- Section 1.1 Name. The name of the corporation is Touchdown Jacksonville Revive the Pride, Inc.
- Section 1.2 <u>Address of Principal Office</u>. The address of the principal office of the corporation is: 3 Independent Drive, Jacksonville, Florida 32202.
- Section 1.3 <u>Mailing Address</u>. The mailing address of the corporation is 3 Independent Drive, c/o Kandi Begue, Jacksonville, Florida 32202.

### ARTICLE II

#### PURPOSES AND POWERS

- Section 2.1 <u>Purposes and Powers</u>. The corporation is organized and shall be operated exclusively for the benefit of the public through the exercise of the following purposes and powers:
  - (a) To coordinate community activities and initiatives in an effort to promote participation and a sense of community within the City of Jacksonville and the surrounding communities in supporting the Jacksonville Jaguars, a National Football League franchise;
  - (b) To develop, promote, assist and encourage professional and amateur sports programs and sporting events for the Northeast Florida area;
  - (c) To improve the economic business conditions of the Northeast Florida area by promoting and producing national or international competition in sports;
  - (d) To exercise all rights and powers conferred by the laws of the State of Florida upon corporations not for profit, including but not limited to those set forth in Florida Statutes Chapter 617 and the following powers: to acquire by bequest, devise, gift, grant, donation, contribution, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the

income, principal and proceeds of such property, for any of the purposes set forth herein;

- (e) To purchase, own, sell and otherwise deal with real and personal property, to borrow and lend money, to make contracts with others for goods and services, to elect officers and appoint agents and to carry on its operations through its officers, employees and agents within or without the State of Florida;
- (f) To engage in and transact any other lawful activity, solely in furtherance of the foregoing powers and purposes, for which corporations not for profit may be incorporated under the Florida Not for Profit Corporation Act, and any successor or amendment to said Act; and
- (g) To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

## ARTICLE III

## **BOARD OF DIRECTORS**

Section 3.1 <u>Election</u>. Directors shall be elected in the manner set forth in the Bylaws of the corporation.

Section 3.2 <u>Number</u>. This corporation shall have twelve (12) Directors initially. The number of Directors may be increased or reduced from time to time, as provided in the Bylaws of the corporation; however, the corporation shall at all times have at least three (3) Directors.

Section 3.4 <u>Executive Committee</u>. The Board of Directors may, pursuant to a resolution adopted by a majority of all of the members of the Board, designate two (2) or more of its members to constitute an executive committee, which, to the extent provided in such resolution, may exercise the powers of the Board of Directors.

# ARTICLE IV

Section 4.1 <u>Limitations on Actions</u>. No dividends shall be paid and no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any director or officer, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Section 2.1 of these Articles. The corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue law) (hereinafter the "Internal Revenue Code").

# ARTICLE V DISSOLUTION

Section 5.1 <u>Dissolution</u>. Upon the dissolution of the corporation, or the winding up of its affairs, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for charitable, scientific or educational purposes in such manner and to such qualified organization or organizations as the Board of Directors shall determine. Any of such assets not so distributed shall be distributed in accordance with the direction of any court having jurisdiction in the county in which the principal office of the corporation is then located, exclusively for the aforesaid purposes of the corporation or to such qualified organization or organizations as said court shall determine. For purposes of this Article, an organization is a "qualified organization" only if, at the time of receiving such assets, it is operated exclusively for the purposes described in Section 170(c)(2)(B) of the Code and is described in Section 509(a)(1), (2) or (3) of said Code.
