Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

ARTICLE I

of The name the corporation shall be Wolves Baseball Organization, Inc. (the "Corporation"). Said corporation is organized exclusively for charitable, educational and scientific purposes such purposes including for the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).
