ARTICLES OF INCORPORATION OF THE ELODIDA DE ADLS INCORPORAL

THE FLORIDA PEARLS, INCORPORATE

ARTICLE I

NAME

The name of this Corporation shall be The Florida Pearls, Incorporated

ARTICLE II

ENABLING LAW

This Corporation is organized in accordance with the corporation's not-for-profit law of the State of Florida, set forth in Part 1 or chapter 617 of the Florida Statutes.

ARTICLE III

PRINCIPAL OFFICE

The principal place of business of this Corporation shall be: 11883 SW 210 Street, Miami, Florida 33177 and mailing address is P.O. Box 343594, Florida City, Florida 33034.

ARTICLE IV

PURPOSE

The purpose for which this Corporation is organized is to provide Scholarships, Educational, Cultural, Community Workshops and Training Programs in the State of Florida.

- 1. This Corporation shall have the power to receive grants and gifts of real property and/or personal property and/or cash to accomplish the above listed purpose.
- 2. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- 3. This Corporation is organized and shall operate exclusively for charitable and educational purposes, which is consistent with Section 501 (C) (3) of the Internal Revenue Code.

- 4. This Corporation is organized, and shall be operated, exclusively for not-for-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.
- 5. No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

ARTICLE V

BOARD OF DIRECTORS

Section 1. Number. There shall be a Board of Directors consisting of not less than three (3) and not more than fifteen (15) persons who shall be of legal age.

<u>Section 2. Manner of Election and Appointment.</u> The authorized number, qualification and manner of election and appointment of members of the Board of Directors to this Corporation shall be as set forth in the By-Laws of this Corporation.
