**ARTICLE I – NAME**

The name of the Corporation is **HEAVEN EMPOWERED – COMMUNITY ASSISTANCE NETWORK, INC.** (hereinafter called the "Corporation").

**ARTICLE II – PRINCIPAL OFFICE**

The street address of the principal place of business office is 1879 S. US Highway 129, Bell, FL 32619 and the current mailing address of the Corporation is PO Box 2146, Trenton, FL 32693.

**ARTICLE III – PURPOSE**
