

Purpose

The Bunch, Inc. is a not for profit social club, and is registered with the Internal Revenue Service as a 501- C(7). The members are bound together by the common objective of pleasure, recreation, and other nonprofitable purposes. The purpose of the club is to provide personal interactions, commingling, and fellowship amongst its members, in a social atmosphere.

The Bunch maintains a limited membership, consistent with its character, and will limit admissions, and will not discriminate in membership opportunities on the basis of race, color or religion.

All members will pay the exact same amount of money to initiate and renew their memberships, with no members being assessed higher dues, or fees. Memberships may be paid by corporations, but there will be no corporate memberships.

The club may limit the voting eligibility of its associate members, if any.

No part of the organization's net earnings may benefit any person having a personal or private interest in the activities of the club. However, a reduction in dues, or an increase in services may provide support to the members. Also, no payments will be made to any member who brings in other members. There will be no plan to provide sick and death benefits instituted.

The members will gather for the exclusive purpose of pleasure and social interaction. These meetings shall be private and exclusive to members, and invited guests only. The public is not allowed to attend.

The club may earn up 34% of its gross receipts, including investment income, from sources outside of its membership. Up to 14% of which may be derived from the use of facilities and services to the general public. Donations to the club are not tax deductable.

The club may acquire and/or lease a meeting hall, but the purpose of such expenditures will be for the furtherance of social activities and not to become a title holding company.
