**ARTICLES OF INCORPORATION OF PROGRESS FLORIDA EDUCATION CENTER
INC.**

(In compliance with Florida Statutes Chapter 617, Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Progress Florida Education Center, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1010 Central Ave. #209 Saint Petersburg, FL 33705.

ARTICLE III PURPOSE

The purpose for which the corporation is formed is charitable work within the meaning provided in section 501(c)(3) of the Internal Revenue Code. The corporation may engage in research and public education to promote progressive ideas within the state of Florida. The corporation is not organized for gain or individual profit. Subject to the foregoing, the corporation shall have and enjoy all the powers conferred upon a non-profit corporation under the laws of the state of Florida

ARTICLE IV CORPORATION NOT PROFIT

The property of the corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the corporation shall be divided among or inure to the benefit of any officer or director of the corporation or any individual or be apportioned for any purposes other than the not-for-profit purposes of the corporation.

ARTICLE V MANNER OF ELECTION

The original Board of Directors shall be selected by the incorporators. The method of election of later boards shall be set forth in the Bylaws.

ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VII INCORPORATOR

ARTICLE VIII DISSOLUTION

Upon dissolution of the corporation, the Board of Directors, after making provisions for the payment of all of the liabilities of the corporation, shall arrange for the distribution of all remaining assets of the corporation to one or more organizations which are exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.
