Pursuant to Florida Statute Section 617.1002 and 617.1006, the Articles of Incorporation of Greater Miami Neighborhoods, Inc., a Florida corporation not-for-profit, are hereby amended as follows:


1. Article III ("Purposes") is amended to add the following language at the end of subsection A of Article III:

"Such purposes shall include, but not be limited to, the provision of affordable housing to very low-income, low-income and moderate-income persons."

2. There are no members entitled to vote on this Amendment to the Articles of Incorporation. This Amendment to the Articles of Incorporation was approved and adopted by a vote of at least two-thirds of the Board of Directors on November 30th, 1998.

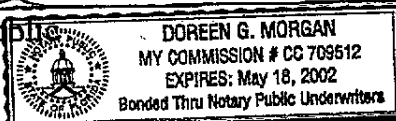
