**Article III will now read:**


**Arts For All Ages, Inc.** is organized exclusively for charitable, research, and educational purposes: to give children the opportunity to experience and experiment with the performing and visual arts, to set up lessons and workshops for anyone who has an interest in learning the arts at no cost, and to increase community awareness about the importance of music and arts in the lives of children. More so, all assets and net earnings of Arts for All Ages, Inc. will be used to further this purpose. Arts for All Ages, Inc. will not engage in any activity not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Service Code, or a corresponding section of a future tax code, or by an organization, contributions of which are deductible under section 170(c)(2) of the Internal Revenue Service Code, or by a corresponding future tax code.

**Article IX (a new article) will now read:**

Upon the dissolution of the organization:

All assets and funds will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or a corresponding section of any future federal tax code, or to the Florida government, for a public purpose. Any assets that are not disposed of in this manner will be disposed of by the Court of Common Pleas of the county Arts for All Ages, Inc. is located in at said time, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. These decisions will be made by the Board of Directors.
