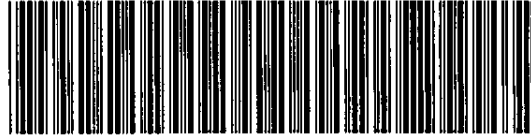



Affiliated with the Gurdjieff Foundation in New York, the Gurdjieff Society of Florida offers a place of contact for those seeking to learn about the authentic oral teachings and methods for the development of consciousness developed by G. I. Gurdjieff.

The Gurdjieff Society of Florida has had a fifty year direct connection with the original pupils of Gurdjieff, thus keeping alive the lineage to his direct teaching. This teaching, known to the followers of Gurdjieff as "The Work" and to the world as the "Fourth Way", is now established in most of the major cities of the world.
