

Amendment - Statement of Purpose

The Gurdjieff Society Inc. is organized exclusively for educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

The Gurdjieff Society of Florida was founded to provide an open educational forum for the study of the philosophy and ideas of G.I. Gurdjieff. The Gurdjieff Society of Florida conducts weekly educational meetings/classes at its location in downtown Fort Lauderdale.

Students come together for discussion of specific ideas related to the philosophy of G.I. Gurdjieff.

Amendment - Dissolution Clause

Upon the dissolution of the Gurdjieff Society of Florida, Inc., its assets shall be distributed for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, to:

The Gurdjieff Foundation Inc., 123 East 63rd Street, New York, NY 10065, a non-profit 501(c)(3) tax-exempt organization with educational purposes similar to those of the Gurdjieff Society of Florida, Inc.

OR shall be distributed to the federal government, or to a state or local government for a public purpose.

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction

in the county in which the principal office of the organization is then located,

exclusively for such purposes or to such organization or organizations,

as said Court shall determine, which are organized and operated exclusively for such purposes.
