

Articles of Amendment To Articles of Incorporation of BE ENCOURAGE HOLINESS MINISTRIES INC.

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Article 1

The name of the corporation shall be: BE ENCOURAGE HOLINESS MINISTRIES INC.

Article 2

The principle office of the corporation for the transaction of its business is located at 441 SAVANNA POINTE STREET, WINTER HAVEN, FLORIDA 33884.

The principle mailing address of the corporation for the transaction of its business is 441 SAVANNA POINTE STREET, WINTER HAVEN, FLORIDA 33884.

Article 3

The purposes of BE ENCOURAGE HOLINESS MINISTRIES INC. (Church of God in Christ) is to engaged in carrying on the original free flow of the anointing of the Holy Ghost out of which God's Holy Church evolved, that is to seek out and save the lost and serve the needy through a continuing service of:
