Makayla Joy Sitton Foundation, Inc. Articles of Amendment to Articles of Incorporation

The Board of Directors of the Makayla Joy Sitton Foundation, Inc., a Florida Not-for-Profit Corporation, hereby amends its original Articles of Incorporation dated January 7, 2010, Florida document number N10000000189 as follows:

Article III

The corporation is organized exclusively for charitable, religious, educational, and literary purposes, including, for such purposes, the making of distributions to organizations that qualify as tax exempt organizations under Internal Revenue Code Section 501(c)(3), or the corresponding section of any future federal tax code.

Article VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article VII

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Internal Revenue Code section 501(c)(3), or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
