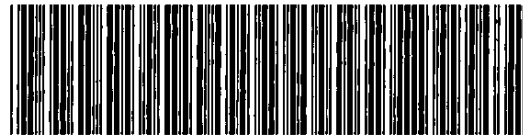

**ARTICLES OF INCORPORATION
OF
JUPITER PARENT GROUP, INC
(A Corporation Not For Profit)**

The undersigned, for the purpose of forming a corporation under Chapter 617 of the laws of the Florida, does hereby adopt the following articles of incorporation:

ARTICLE I NAME

The name of this Corporation shall be:

JUPITER PARENT GROUP, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

ARTICLE III PURPOSE

The purposes for which the corporation is to be formed are:

- To raise funds for Educational and Social goals for low income, economically needy families with children
- To provide an open process by which enrollees parents/guardians(s) may get involved in the affairs of the JPGI.
- To obtain sponsorship and to raise funds for the Parent Group and for other educational and social goals.
- To Act as a group to influence decisions affecting JPGI.
- To work toward establishing a volunteer pool of individuals for the purpose of supporting the Jupiter Center and staff in carrying out the functions of the program's mandates.
- To do and perform all of the activities related to said purposes, **including those purposes stated in the article of incorporation of the Jupiter Parent Group, Inc. (A Corporation Not – For Profit)**

and to have and enjoy all of the powers granted and engage in any lawful activity for which corporations may be organized.

Notwithstanding any statement of purpose or power aforesaid, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of its primary purpose.

To receive and maintain funds of real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or part of the income there from and the principles literary, or educational purpose either directly or by contributions under Section 501(c) of the Internal Revenue Code and its Regulations as they now exist or may hereafter be amended.

ARTICLE IV INITIAL DIRECTORS/OFFICERS

The people who are to serve as the initial officers/ directors until their successors are elected as follows: The elections shall be held at the first parent meeting of the new school year with a majority vote. The officers shall consist of parent, guardians or grandparents with children attending Jupiter Head Start Center, and who are interested in pursuing the goals of the corporation.

The general officers of the corporation shall be a Chairperson, Vice Chairperson, Secretary and Treasurer. The chairperson shall be the Chief Executive officer. These officers shall be members of the Board of Directors, and perform such imposed duties by the Jupiter Parent Group and by-laws.




