

### ARTICLES OF INCORPORATION

### ARTICLE I NAME AND IDENTITY

The name of this corporation is: Iq Balam, Inc.

### ARTICLE II STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation solely for charitable, religious, educational and/or scientific purposes pursuant to the Florida Corporations Not for Profit Law set forth in Part 1 Chapter 617 of the Florida Statutes.

No substantial part of the activities of the organization shall be of carrying on propaganda, or otherwise attempt to influence legislation. The organization shall not participate in, or intervene in (including the publishing or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or corresponding section of any future tax code, or (b) by an organization contributions to which are deductible under section 17-(c)(2) of federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

## ARTICLE XII DISTRIBUTION OF ASSETS FOR ACTIVITIES
