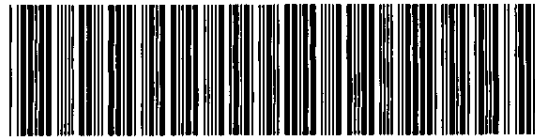

Article III Purpose (s)

The specific purpose(s) for which the corporation I organized is (are): said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third here of. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or (b) by a Corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

Article IV Manner of Election

The manner in which the directors are elected or appointed is as follows:

The President of the corporation shall be Elder Jerome Cox, for the duration of the corporation, unless otherwise installed by the Presiding Jurisdictional Prelate of the Western Florida Jurisdiction, Church of God in Christ, Inc., according to the guidelines of the constitution of the Church of God in Christ, Inc., National Headquarters located in the City of Memphis, Shelby County, Tennessee, or otherwise stated in the bylaws of this Corporation. The election and appointment of other directors shall be stated in the bylaws of the Corporation.
