

## Attachment to Articles of Incorporation of Nurture via Nature, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to raises funds to purchase nutritious foods from local farmers markets, to be donated to surrounding food banks. It has become widely researched, and accepted, that malnutrition affects both physical and psychological development in children; as well as adults. It is our intent to provide nutritious food to foods banks by supporting local farmers markets. Due to the low cost of highly processed foods, most food banks receive donations of unhealthy food. By donating only food from local farmers markets, we are not only supporting food banks to help provide healthy food to those in need, we are supporting local vendors committed to providing consumers with nutritious food.

Our core means of donations will come from donation jars placed next to the cash registers of local farmers markets. We will request the vendor to proudly place the donation jars next to their check out, and offer consumers to donate money to our cause. Our staff/volunteers will periodically go to the farmers market, count the donations, and directly purchase fruits, vegetables, grains, etc. from the farmers markets which have generously allowed our jars to be displayed. As soon as the food is purchased, it will be brought to the nearest food bank. Each farmers market will support the food bank closest to their location.

For every one dollar collected, eighty cents will be used. The remainder twenty cents will pay for overhead expenses. Since we will be accepting direct donations as well, the donator will either specify a particular farmers market or area food bank to support. If a donator does not request a particular farmers market or area food bank, the donations (eighty cents on every dollar) will be deposited in the Nurture via Nature, Inc. trust. The funds will be divided amongst the participating farmers markets (and their surrounding food banks).

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in.

or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
