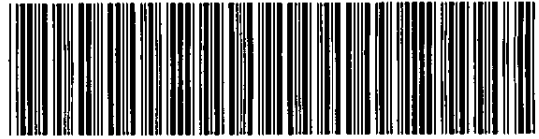

Pursuant to F.S.S. 617.1402 and 617.1403 of the Florida Statutes, Change This World, Inc., a Florida not for profit corporation, hereinafter (the "Corporation"), submits the following articles of dissolution:

1. The name of the Corporation is Change This World, Inc.; and
2. The effective date of dissolution is October 31st, 2015; and
3. The Corporation has no members and the dissolution was approved by the board of directors on September 14th, 2015. The number of votes cast for dissolution was sufficient for approval; and
