## ARTICLES OF INCORPORATION PALLIANASSEE. FLORIDA

#### Article I NAME

The name of this corporation shall be THE RONSHAY FOUNDATION, INC. (hereinafter called the "Corporation").

#### Article II PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is 934 Cochran Dr, Tallahassee, FL 32301-7022.

#### Article III **PURPOSE**

This Corporation is a not-for-profit corporation, organized and to be operated exclusively for charitable purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit. More specifically, the Corporation is organized and shall be operated exclusively to carry out the following purposes:

- To serve and provide services to incarcerated parents and their children, as well as (a) caregivers;
- To provide assistance and support to programs that aid incarcerated parents, children, and caregivers;
- To support efforts to encourage safety and prevent tragedy on the highways. (c)
- To carry on such other activities in furtherance of and support of the foregoing purposes as are lawful and proper for corporations formed under the Florida Not-For-Profit Corporation Act and section 501 (c)(3) of the Code.

#### Article IV **MEMBERSHIP**

The Corporation shall have no members.

## Article V INITIAL REGISTERED OFFICE AND AGENT

The Street address of the initial registered office of the Corporation is 934 Cochran Dr, Tallahassee, FL 32301-7022, and the name of the Corporation's initial registered agent at that address is Cavetta Corbett.

#### Article VI BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors. The number of directors shall initially be three. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner of election members of the Board of Directors shall be regulated by the Bylaws of the Corporation. The names and addresses of the persons who shall serve as the initial members of the Board of Directors and Officers of the Corporation are as follows:

## Article VIII DISSOLUTION

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Code or corresponding provisions of any subsequent federal tax laws, as selected by the Board of Directors.

### LIMITATIONS

distributable to, its trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of activities of the Corporation shall be carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (in) of section 501 of the Code), and the Corporation shall not participate or intervene in (including the publishing or distributing of statements) any political campaign on behalf or any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from receral income tax under section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code (or the corresponding provision of any future United States Internal Revenue Law).
