## CIVIC LEAGUE OF HAITIAN-AMERICAN VOTERS, INC amending of articles (additional page)

### **PURPOSE**

Civic League of Haitian American Voters (CLHAV) is organized and operated exclusively for charitable and educational purposes within the meaning of section 501(c) (3) of the Internal Revenue Code. It teaches civic education like knowledge about public affairs and how to participate effectively in the life of the community. It teaches skills of meaningful and regular community service program. It enables adult volunteer to work with youths on tangible after school projects, such as, story writing, website building, etc. It contributes and strengthens through civic education the level of civic engagement in the Haitian community; increases participation and deliberation from team sport and organized altruism to grassroots social movements.

#### OPERATIONAL LIMITATIONS

The Civic League of Haitian American Voters (CLHAV) is a non profit, non partisan Community Based Organization (CBO). It is a civil society organization aiming at the public good, totally independent of government. (Art. 4&5).

Notwithstanding any other provisions of these articles, the Civic League of Haitian American Voters (CLHAV) shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions, to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

### **DISSOLUTION CLAUSE**

Upon the dissolution of the Civic League of Haitian American Voters, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of CLHAV, dispose of all the assets of CLHAV exclusively for the purposes of the organization in such manner, or to such organization or organizations organized and operated exclusively for educational or charitable purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future U.S. Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which CLHAV's principal office is then located, exclusively for such, purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
