

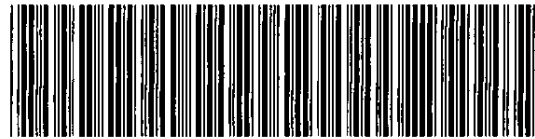

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which ***God's Call To Women of Authority*** is organized is: To build up the Kingdom of God right here on earth with the programs and services rendered. The programs AES (Adults empowered to succeed) and YES (Youth empowered to succeed) which is a multi-racial, ethnically-diverse educational and community service organization specializing in the encouragement and development of inter-group relations and community organization. ***GOD's Call To Women of Authority, Inc.*** programs seeks to enable men, women, youth, African Americans and other minority group members to cultivate and exercise their full human potential on a par with all other Americans.

**ARTICLE VII** - The corporation is organized exclusively for and will operate exclusively for, charitable, religious, educational and scientific purposes as indicated under section 501©(3) of the Internal Revenue Code.

**ARTICLE VIII** – No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

**ARTICLE IX - DISSOLUTION**

Upon the dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
