**ARTICLES OF INCORPORATION
OF
Miami Progressive Project, Inc.
A Florida "Not for Profit" Corporation**

The undersigned, a natural person of the age of eighteen or over, certifies, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is Miami Progressive Project, Inc. (the "Corporation").

ARTICLE II

The principal place of business is 2555 Collins Avenue, #812, Miami Beach, FL 33140 and the mailing address of the corporation is 1602 Alton Road, #28, Miami Beach, FL 33139.

ARTICLE III

The purposes for which this corporation is formed are exclusively charitable and educational and consist of the following:

Developing new young local leadership and a new source of political talent for South Florida, with the goal of creating a new progressive leadership class in every sector of the political strata, working from the bottom up and under democratic principle to lessen neighborhood tensions, eliminate prejudice and discrimination, promote and defend human and civil rights, and combat community deterioration and juvenile delinquency.

ARTICLE IV

The manner in which directors are elected or appointed shall be stated in the bylaws.

ARTICLE V

The name of the registered agent of the corporation is Aidil Oscariz. The address of this registered agent is 2555 Collins Avenue, #812, Miami Beach, FL 33140

ARTICLE VI

The name and address of the incorporator is: Alvaro Fernandez, 2555 Collins Avenue, #812, Miami Beach, FL 33140.

ARTICLE VII

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VIII

Notwithstanding any other provision of this certificate, the Corporation is organized exclusively for charitable, cultural or educational purposes, and intends at all times to qualify and remain qualified as exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code") (or the corresponding provision of any future U.S. Internal Revenue Service rule or regulation) and, in connection therewith:


- (a) The Corporation is not formed for and shall not be conducted nor operated for pecuniary profit or financial gain, and no part of its assets, income or profit shall be distributed to or inure to the benefit of any private individual or individuals, provided that nothing herein shall prevent the Corporation from paying reasonable compensation to any person for services rendered to or for the Corporation in furtherance of one or more of its purposes;
- (b) No substantial part of the activities of the Corporation shall be devoted to the carrying on of propaganda or otherwise attempting to influence legislation, except to the extent permitted by the Code whether pursuant to an election under Section 501(h) or otherwise, and no part of the activities of the Corporation shall be devoted to participating or intervening in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office; and
- (c) The Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provisions of any future U.S. Internal Revenue Service rule or regulations) or (ii) by a corporation contributions to which are deductible under section 170(c)(2) of the Code (or the corresponding provision of any future U.S. Internal Revenue Service rule or regulation).

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
