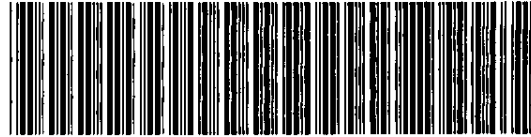

Adding to Article III: Praxis International, Inc. (Hereafter "Praxis") is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the IRC corresponding section of any future federal tax code.

No part of the net earnings of Praxis shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Praxis shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes setforth in the purpose clause hereof. No substantial part of the activities of Praxis shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and Praxis shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Nothwithstanding any other provision of this document, Praxis shall not carry on any other activities not permitted to be carried on by an organization: (a) exempt from federal income tax under section 501(c)(3) of the IRC or (b) contributions to which are deductible under section 170 (c)(2) of the IRC; or corresponding section of any future federal tax code.


