ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WILDLIFE FOUNDATION OF FLORIDA MITIGATION TRUST FUNDS, 10: 43 INC. SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not-forprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article 3, Corporate Purposes is amended to read:

Article 3. Corporate Purposes

The Corporation shall be a member, nonprofit organization formed and operated within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3). The sole or primary function of the Corporation is to provide funding for the maintenance and land stewardship of projects established by trust agreements entered into by various grantors with the Corporation or Wildlife Foundation of Florida, Inc. for the protection of natural resources and serve as trustee of such trusts.

Pursuant to Sections 617.1001, 617.1002, and 617.1006, Florida Statutes, and in accordance with Article 6 of the Articles of Incorporation of the Corporation, by unanimous vote of the Board of Directors authorized and consented in writing on <u>Feb. 3</u>, 2010, to the filing of these Articles of Amendment to Articles of Incorporation.
