The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

ARTICLE I – NAME

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 © of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The corporate power of this corporation is as provided in section 617.0302, Florida Statutes. There are no provisions limiting the powers of the corporation except as prohibited by section 617.0833

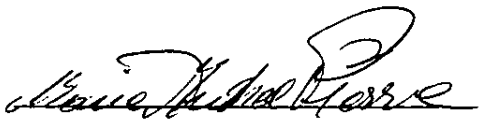

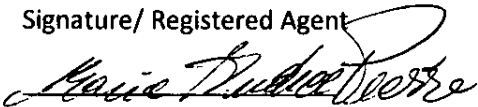

Section I.

This Corporation shall be operated and governed by a Board of Directors.
