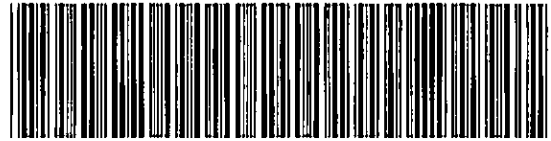

Article III of the Articles of Incorporation is deleted in its entirety and will be replaced with the following language:

The specific purpose of the corporation is to prevent children and young adults from using drugs, nurture their health and fitness, and keep them off the streets. The corporation will accomplish this objective by training young people in self-defense, teaching them various aspects of the martial arts, and helping them realize the importance of teamwork and positive self-esteem. The corporation will further promote cardiovascular fitness and stem obesity to both adolescents and adults through health and fitness training. Finally, the corporation will support and train law enforcement personnel in hand-to-hand combat skills and coach other means of neutralizing an attacker.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
