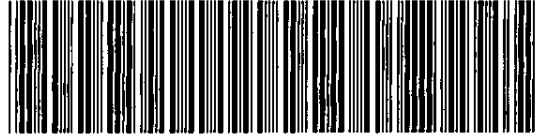



ARTICLES OF INCORPORATION  
FOR  
TABERNACLE OF PRAYER OF KISSIMMEE, FLORIDA INC  
(A Non for Profit Corporation)

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: Tabernacle of Prayer of Kissimmee, Florida Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of allowing a group of believers with the same ethnic and cultural background to jointogether as a church to seek the lost souls for Jesus Christ and who are also willing to be conformed with the law of the State of Florida.

ARTICLE IV - CHARITY PURPOSES

The corporation shall be formed, maintained, and operated for charity purposes as provided in section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future Internal Revenue Code. Also, all assets of the corporation shall be dedicated to the purposes described in these Articles of Incorporation.




