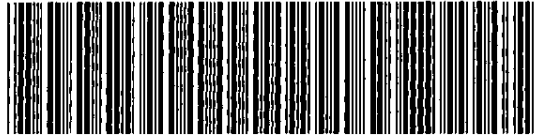

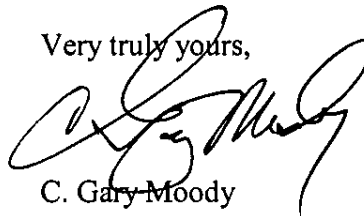

ARTICLES OF INCORPORATION

OF

**MID FLORIDA HISTORICAL RESEARCH
AND RECOVERY ASSOCIATION, INC.
(a non-profit corporation)**

ARTICLE I

The name of the corporation shall be Mid-Florida Historical Research and Recovery Association, Inc., and it shall be a non-profit corporation.

ARTICLE II.

The principal place of business and mailing address of the corporation and its registered office is 9699 SW 99th Avenue, Ocala, Florida 34481.

ARTICLE III

The main purpose of the corporation is to provide aid to the general community and to law enforcement, in recovering lost items from the present and the past, and, to research, recover and preserve historical artifacts.

ARTICLE IV

The period of the duration of this corporation shall be perpetual , unless dissolved according to, or by operation of, Florida law.

ARTICLE V

This corporation shall have no shareholders, but shall have members. The qualification for membership, and the manner of their admission as members of the corporation shall be as set forth, in, and shall be regulated by, the By-laws of the corporation.
