



ARTICLE III PURPOSE

Exclusively for charitable, professional, educational and civic purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

The purpose for which this corporation is organized is to provide and promote the awareness of the needs of families, adults and children without regard to age, sex, color, creed, religion, or national origin and for that purpose:

- a. to financially assist youth participating in mission trips to assist needy adults, children and families when those trips are organized by exempt organizations under section 501 (c)(3) of the Internal Revenue Code;
- b. to plan and oversee mission trips for purposes of assisting the needy adults, children and families with their specific needs; to include but not limited to minor home repairs, cleaning and general maintenance;
- c. to provide supplies for distribution and/or use on mission trips organized by exempt organizations under section 501 (c)(3) of the Internal Revenue Code for purposes of assisting the needy adults, children and families with their specific needs;
- d. to employ a director to design, coordinate and implement the program and to oversee daily operations;
- e. to transact any an all lawful business which nonprofit corporations may conduct pursuant to the laws of the State of Florida and section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code;

Article VIII Dissolution of Corporation

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code mandates, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a court of competent jurisdiction in Seminole County, Florida where which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
