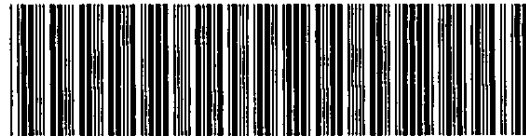

Article III (addition to existing language)

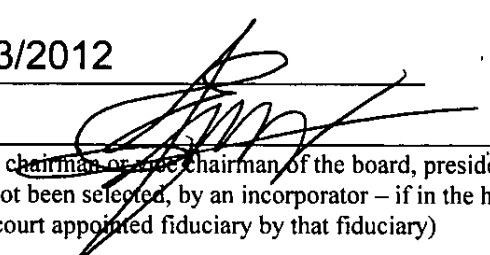
