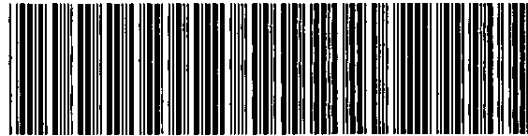

ARTICLE I: New Life Ministry Prophecy in Motion

The name of this ministry is New Life Ministry Prophecy in Motion, Located in Key West Florida Monroe County.

Section 2: PURPOSE:

(A)The primary purpose of this ministry is to reach the lost and dying souls, through the word of God leading them into a personal relationship with Jesus Christ as Savior and Lord. (John 3:16), to see individuals heal emotionally as they grow in faith toward God and in the knowledge of His Word, to equip Christians for works of service, encouraging spiritual growth and helping them to recognize and develop their God-given gifts through the teaching of the Bible, the ministry of the Holy Spirit, and worship (2 Timothy 3:16-17, I Corinthians 12:4-10, Ephesians 4:12-13, John 4:24).

Article II. Mission Statement

We are committed to working in the vineyard as soul winners and labors to spread the gospel of the Lord. And to compel sinners to repent and to come into salvation and God's saving grace. We shall seek out appropriate services, counsel, training, and expertise to send out well versed and trained Christians who have a zeal to go out into the world to promote evangelism and missionary work in all places, and to establish and organize churches and foster their development to further the Kingdom of God (Mark 16:15).

This ministry is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law). These charitable, religious, and educational purposes include, but are not limited to, establishing and maintaining of religious worship, the building, maintaining and operating of churches, schools, chapels, radio stations, television stations, rescue missions, bookstores, daycare centers, camps, coffee houses and any other ministries that the church may deem appropriate in obedience to the will of God.

This ministry is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law). These charitable, religious, and educational purposes include, but are not limited to, establishing and maintaining of religious worship, the building, maintaining and operating of churches, schools, chapels, radio stations, television

stations, rescue missions, bookstores, daycare centers, camps, coffee houses and any other ministries that the church may deem appropriate in obedience to the will of God.

ARTICLE III: STATEMENT OF FAITH

The fundamental teachings of this ministry reflected in the following statements:

WE BELIEVE the Bible to be the inspired, infallible, and authoritative Word of God. The Holy Spirit moved upon the writers of the Old and New Testament and inspired them as they wrote the Words of God. God's revelation in Christ and in scripture is unchangeable. Through it the Holy Spirit still speaks today. (II Tim. 3:13-17; Heb. 4:12; Psalm 119:89, 105; I Pet. 1:23-25; Gal. 1:8, 9; Matt. 5:18; Isa. 40:8)

WE BELIEVE that there is One God, eternally existent in three personalities: Father, Son, and Holy Spirit God the Father creator of all things. By His Word all things were created and through the power of His Word all things are held together. He sent His Son Jesus to redeem mankind unto Himself. A relationship with God only comes through Jesus Christ. Jesus Christ—is the only begotten Son of God, conceived by the Holy Spirit, and born of a virgin. He lived a sin-less life, and performed many miracles. He redeemed us by His atoning death through His shed blood; He ascended to the right hand of the Father,

We BELIEVE that God will personally return in power and glory. There is no other name given under heaven by which man must be saved. Holy Spirit—inspired the writers of the Bible, convicts the world of sin, teaches us all things, and brings to our remembrance the Word of God. (Deut. 6:4; Isa. 44:6-8; Isa. 43:10; Matt.3:16, 17; Matt. 28:19; I Cor. 12:4-6; John 14:23, 25; I Tim. 6:15, 16; I John 5:7)

WE BELIEVE that mankind is perishing because of sin, which separates him from God. But God loves all mankind, not wishing that any should perish, but that all should repent. Mankind can only be saved through a complete commitment to Jesus Christ as Lord and Savior, being regenerated by the Holy Spirit.(Gen. 1:26, 31; Psalm 8:4-8; Gen. 3:1-7; Rom. 5:1, 12-21; Eph. 2:8, 9; Acts 3:19-21; I Cor. 15:21, 22; Gal. 6:14, 15; II Cor. 5:17)

WE BELIEVE in the present infilling of the Holy Spirit to all believers who desire it. The Holy Spirit's ministry to the body of Jesus Christ gives power to live, witness, proclaim the gospel and to make disciples. The Holy Spirit gives us power to cultivate a Christ-like character through the Fruit of the Spirit and to build up and mature the church through the miraculous gifts and ministries in this present day. (John 15:8-10; I Cor. 12:13; John 3:5, 6; Acts 1:4-8; Acts 2:1-4; Acts 2:38, 39; Luke 11:9-13; Joel 2:28, 29; I Cor. 12-14; Heb. 2:4)

WE BELIEVE that the local church is a body of believers brought together by the Holy Spirit as a visible part of the body of Christ and His church universal. The church is responsible to faithfully proclaim the whole Word of God in fulfilling the Great Commission, properly administer the sacraments, and humbly submit themselves to discipline, all for the glory of God. (Matt. 28:19, 20; Rom. 12:4, 5; I Cor. 12:27; Eph. 2:22; I Pet. 2:5, 9, 10; Titus 2:14)

WE BELIEVE that all mankind shall give an account of their deeds in this earthly life before the judgment seat of Christ. Those with their names written in the Lamb's Book of Life will be eternally with God in His glory; those without their names written will be eternally separated from God and tormented. (I Thess. 5:13-17; Rev. 1:7; Acts 1:11; Rev. 20:10-15; II Cor. 5:10; II Thess. 1:7-10; Rev. 21:1-4)

ARTICLE IV: MEMBERSHIP/FELLOW SUPPORTERS

In the spirit of unity and peace we believe in the in gathering of the people of God. As we come together as one body to pray, worship, and fellowship. For those persons who may be interested in becoming apart of this organization should be committed to the mission and the vision of the ministry. It is expected that those individuals who desire to enter into this spiritual bond and relationship of ministry, will do with honest and pure intentions. Members and fellow supporters are expected to help build the house of God and not tear it down by words, actions or underlying deeds. The Bible teaches clearly that if two are going to walk together, there must be an agreement (Amos 3:3). If people are going to come into a covenant relationship that is genuine and meaningful there must be a strong foundation for that relationship to be built upon. Membership is a public declaration of that covenant relationship based on shared vision, beliefs, practices and trust.

:

- (A) Made a confession of faith in the Lord Jesus Christ as their Lord and Savior.
- (B) Agree with the Statement of Faith as stated under Article II.
- (C) Live a lifestyle that is consistent with Christian conduct and doctrine.
- (D) Regular attendance at the activities of New Life Ministry and Prayer line.
- (E) Demonstrated a financial commitment by tithing and free will offerings to the New Life Ministry.
- (F) Voluntary submission to the spiritual oversight of New Life Ministry
- (G) All members are encouraged to pray for each other, the leadership and ministries of New Life Ministry

ARTICLE V: BOARD OF DIRECTORS

All board members will be selected by the President and leader of New Life Ministry. The appointed members of the team shall serve as the board of directors. They shall be responsible for the overall vision, direction, and focus and shall fully control, govern and operate the business affairs of the church. As a Partner of New Life Ministry Prophecy in Motion, we submit to the vision, mission, basic values, and guiding principles of this ministry.

The board of directors shall be comprised of the ministers, elders, laymen and woman, the senior pastor or leader who will head the Board. The board of directors shall be the governing body of the church and shall transact church business and act as legal trustees, have supervision over all endowment and trust funds, see that an independent financial report be done annually, and ensure that adequate insurance coverage is maintained, and perform such duties as are required by the laws of the board of directors shall consist of a minimum of three (3), there shall be the president, secretary and treasurer, board members may be added as the need arises, these being taken from qualified members who shall agree with the Statement of Faith (Article II), and have a desire to serve in leadership and are qualified to serve as stated in Article VI,

ARTICLE VI: CHURCH ROLES AND RESPONSIBILITIES

(A) Duties of Secretary

It shall be the duty of the secretary to keep an accurate record of the proceedings of the meetings of the board and of the yearly or special congregational meetings of business, and all such other duties as pertain to this office as may be prescribed by the Board.

(B) Duties of Treasurer

The treasurer shall oversee the care and custody of all funds, securities and deposits of the church in such bank or banks as the board of directors may select. The board of directors shall, by resolution fix all matters of signatures at the point of taking office, which shall continue during the tenure of office, or until changed by the board of directors.

The treasurer shall at all reasonable time exhibit his books or accounts to any member of the board of directors or committee appointed by the senior pastor for that purpose where such inspection is requested by the board on that subject.

(C) Outreach Coordinator

The outreach coordinator will play a vital role in creating effective ways of reaching souls and ministering to the needs of those within the community. The coordinator will be responsible for communicating ideas and programs to the board that will prove to be beneficial to the well being and stability of the people of God. This may include but is not limited to feeding the homeless, sick and shut in, children and youth, battered and abused, and other programs that God may impress on upon our hearts.

(D) Ministry Event Coordinator

Throughout the operation of this ministry we will host various events that will allow the saints of God to come together. As well as other individuals who may want to be a part of what we are doing. The coordinator will work with the leader in efforts to put forth the vision of the event. In a manner that will reflect God's love and our servitude towards His people. This will be done in the spirit of humility and excellence as we desire to be a blessing as well as glorifying the Lord. The coordinator will assist in securing venues and reservations for different events. This may include but is not limited to catering, floral arrangements, programs, order of services, and other duties that may need to be executed in order for things to run properly.

(F) Team Support/Prayer Partner

This individual shall be appointed by the pastor or leader to serve as apart of the ministry structure. They shall serve as source of spiritual strength and covering for the man or woman of God. They will assist the leader in the vision and planning of what the ministry has been called to do. They maybe called upon in certain situations to help with mediation or situations that may need another spiritual leader. This person must keep confidence and able to uphold the servant of God through praying and fasting.

(G) Ministry Assistant

The Ministry Assistant will be appointed by the pastor or ministry leader. The ministry assistant will assist the staff with administration and communication so that tasks contribute to the accomplishment of our multiple ministries. In the absence of the leader the assistant shall carry forth ministry business accordingly. Shall work with the leader to oversee that the vision and mission of the ministry is done. Shall express a willingness and ability to learn and develop new

skills that will benefit the ministry. The candidate must be able to work well with all staff, volunteers and congregational members, children as well as adults.

(G) All Clergy ministers, elders, deacons, etc.

Elders

Elders shall oversee and govern the ministry of the church and demonstrate leadership by personal example under the direction of the Leader or pastor. They shall meet the spiritual needs of the church through visitation, counsel, hospitality, mediation of disputes among members, study and ministry of the word, and prayer. They shall meet together, pray, and review the progress of the church.

Expectations of Elders:

- (1.) An elder must be a “born-again” believer in Jesus Christ and must agree with the Statement of Faith, Constitution and By-Laws of New life Ministry
- (2.) An elder is called to lead by example (I Peter 5:3, I Timothy 3:1-7, Titus 1:5-9). Therefore, we believe that the individual who are selected to this position should be those who have a firm conviction and understanding of leadership by service to others (I Corinthians 10:22-33, Romans 14:13-23).
- (3.) An elder shall be of outstanding moral character, temperate, prudent, honest, gentle, not self-willed, self-controlled, just, devout, and not covetous. If married, he must be in a monogamous heterosexual relationship.
- (4.) An elder shall be one who manages their home well, and if married, whose wife and children follow his example.
- (5.) An elder shall be one who conducts themselves with integrity, is hospitable, has a good reputation in his community and business relations, is not given to drunkenness, is not belligerent, and is not contentious or quarrelsome.
- (6.) An elder shall be a mature believer who is knowledgeable in the Scriptures and who is able to teach, exhort, and convince. Deacons shall carry on various ministries within the church to meet the physical needs of the church under the direction of the senior pastor and elders. In cooperation with the senior pastor, they shall make provision for the observance of the ordinances of the church, pray for those in their care, assist in the disbursement of benevolence funds, care for the work of ushering and extending the official hospitality of the church to its members and visitors.

Deacons

The deacons shall assist the senior pastor, ministry staff, and elders in caring for the administrative needs of the church's various ministries as directed by the senior pastor and is assigned specific tasks that minister to the physical needs of the church and its members. He must be full of wisdom, faith, and have a good reputation (Acts 6:3-6).

Expectations of Deacon/Deaconess

- (1.) A deacon shall be respectable, maintaining a pure conscience before God and man, careful in speech, sincere, not given to drunkenness, not greedy for money, and trustworthy. If married, he must be in a monogamous heterosexual relationship. (I Timothy 3:8-11).
- (2.) A deacon shall manage their home well, and if married, whose wife and children follow his example (I Timothy 3:12).
- (3.) A deacon shall serve the Lord and others and have demonstrated this commitment prior to becoming a deacon.

SENIOR PASTOR / MINISTRY LEADER

The senior pastor or ministry leader acts as the spiritual authority of the local church or ministry. Shall perform the following duties for an indefinite period unless otherwise delegated. The leader shall be of moral character and called by God to operate in this capacity. Must have a Sheppard's heart and is willing to sacrifice time and efforts to lead the people to spiritual victory. Must deal with God's people in all sincerity and not for material gain or selfish motives. Preach the word of God through sound doctrine and give reproof if necessary. Maintain order within the ministry to the best of their ability to ensure that the flow and move of God will not be hindered.

- (1.) Dedicated to a life of fasting and prayer.
- (2.) Studying the scriptures and word of God to feed to the flock.
- (3.) Continued education through workshops, seminars, special classes and or universities that will help to better equip the leader to serve God's people.
- (4.) Schedule yearly training for all clergy and staff
- (4.) Supervise the teaching ministries of the church
- (3.) Provide nurturing care and counsel to the congregation regarding spiritual growth and development

- (4.) Act as moderator at all church business meetings (unless delegated to another person for a specified time)
- (5.) Serve as the president of the corporation
- (6.) Supervise the day-to-day business affairs of the church

Article VII: How to handle issues of conflict

- 1.) Pray for wisdom, discernment, and direction for the person or persons involved.
- 2.) Seek insight from other pastors or leaders who have experience in this area.
- 3.) Outline the problem in writing and pros and cons on conflict document the steps that led to the conflict.
- 4.) Make a plan of action to address the issue.
- 5.) Address the issue directly this usually involves sitting down with the two parties and one person acting as the mediator.
- 6.) Hear both sides of the issue from both parties.
- 7.) Be careful not to attack the individual or allow parties to attack each other.
- 8.) Speak in a clear calm voice so that your concerns may be heard. Do not become irate or disrespectful.
- 9.) If you feel that you can't contain yourself it may be wise to take a 5-10 minute break to regroup.
- 10.) Make a common resolution to the problem together for actions to heal the breach.
- 11.) If the person is unwilling to do so follow through for your own peace.
- 12.) Forgive the person or persons involved that you won't become stagnated spiritually or naturally.

13.)Evaluate your actions to see what you can learn from this experience? Ask yourself was it your fault? How can I do better in the future? Do I need to seek counsel for anything in my life?

14.)Be a peacemaker extend grace, mercy, love, and forgiveness

These are some scripture references that may help regarding in these matters

Ephesians 4:26 “Be angry and sin not, do not let the sun go down on your wrath”

Proverbs 15:1 “A gentle answer turns away wrath, but a harsh word stirs up anger”

Philippians 2:3-4 “Let nothing be done through selfish ambition or conceit, but in lowliness of mind let each esteem others better than himself. Let each of you look not only for his own interest, but also for the interests of others.

Article VIII: BUSINESS MEETINGS

A quarterly business meeting of the ministry shall be held, at which time shall be appointed by the pastor or leader. Notice of special meetings shall be given either verbally or in writing to each board member. No other business shall be conducted other than that for which the special meeting is called unless agreed to by all board members.

At this time all questions concerns and ideas maybe expressed at this time. Each board member should present his or her concerns in a dignified manner giving respect to other members as well. All board members are expected to attend scheduled meetings to discuss ministry business and operations. In the event that you are not able to make it please be respectful to inform leadership or another member as to your intentions.

ARTICLE IX: CHURCH FISCALCHURCH FISCAL YEAR

The fiscal year of the church shall begin January 1st and end December 31st

Article X: DESIGNATED CONTRIBUTIONS

From time to time the church, in the exercise of its religious, educational, and charitable purposes, may establish various funds to accomplish specific goals. Contributors may suggest uses for their contributions but shall be deemed advisory rather than mandatory in nature. All

contributions made to specific funds or otherwise designated shall remain subject to the exclusive control and discretion of the Board of Directors. No fiduciary obligation shall be created by any designated contribution made to the church other than to use the contribution for the general furtherance of any of the purposes stated in Article I, Section 2.

Article XI: Dissolution

Section 1-By Board

In the event that this organization shall be dissolved and liquidated, after paying or making provision for the payment of all liabilities of this organization, the Eldership Team shall distribute or dispose of any remaining property and assets to such organization or organizations established and operated exclusively for religious purposes as, in its judgment, have purposes which are most closely allied to those of this organization.

SECTION 2 - DISSOLUTION BY COURT

Any of this organization's property and assets not disposed of in accordance with ARTICLE IX, Section 1, shall be disposed of by the court having jurisdiction of the dissolution and liquidation of a nonprofit corporation organized and existing under and in accordance with the laws of the Commonwealth of Pennsylvania and having jurisdiction in the county of this organization's registered office exclusively to such religious organization or organizations, each of which is established and operated exclusively for such purposes as are most closely allied to those of this organization and each of which, at the time of such disposal,

Article XII: Amendments

This constitution may be revised or amended by a vote of the board of directors, at a church business meeting, specifically called for the purpose of amending the constitution, provided that the revision or amendment has been submitted in writing fourteen (14) days prior to the meeting. All amendments must be approved by a minimum of eighty percent of all elders.

New Life Ministry By-laws

1. The board of directors will meet at least quarterly. Minutes of the meeting will be kept, and become part of the permanent church records.
2. The following order shall be observed in church business meetings: Prayer, reading of the minutes of the previous meeting, unfinished business, new business, prayer, and adjournment.
3. These by-laws may be altered, suspended, or amended at any church business meeting by an 80% approval vote of all the elders.
4. Members may use the facilities of the church with prior approval.

New Life Ministry By-laws

1. The board of directors will meet at least quarterly. Minutes of the meeting will be kept, and become part of the permanent church records.
2. The following order shall be observed in church business meetings: Prayer, reading of the minutes of the previous meeting, unfinished business, new business, prayer, and adjournment.
3. These by-laws may be altered, suspended, or amended at any church business meeting by an 80% approval vote of all the elders.
4. Members may use the facilities of the church with prior approval.


