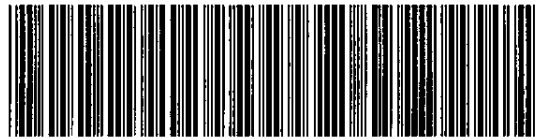

The undersigned, for the purpose of forming a not for profit corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is Masud Temple No. 69 of the Ancient Egyptian Arabic Order Nobles Mystic Shrine of North and South America, Incorporated.

ARTICLE TWO

CORPORATE DURATION

The duration of the corporation is perpetual.

PURPOSES

The general purposes for which the corporation is organized are:

The corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes under Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE FIVE

Basis of Operation

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the origination shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purposes clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE SIX

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4962 Victoria Circle, West Palm Beach, Florida 33401, and the name of the its initial registered agent at such address is Jeffery G. Jones.

ARTICLE SEVEN

ELECTION OF DIRECTORS

The Board of Directors shall be elected annually by the members of the corporation in the manner provided in the bylaws.

DISSOLUTION

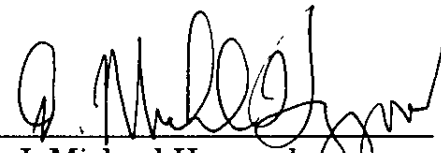
