ARTICLES OF INCORPORATION OF ALL FAITH VISION CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I NAME

The name of the Corporation shall be: All Faith Vision Corporation.

Article II PRINCIPAL OFFICE

The place in this State where the principal office of the Corporation is to be located is: The City of Miami, Miami-Dade County.

The principal street address and mailing address is: 15960 SW 102 AVE, Miami, FL 33157, USA

Article III PURPOSE

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. All Faith Vision Corporation, a not for profit charitable organization, is a public charity which limit the organization's purposes to exempt purposes set forth in section 501(c)(3) and does not expressly empower it to engage, except to an insubstantial degree, in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

All Faith Vision Corporation is a humanitarian organization dedicated to working with children, families, and their communities worldwide to help break the cycle of poverty to relieve human suffering and to provide hope for self development in a charitable manner. All Faith Vision Corporation is a public charity effort which the income received from the conduct of activities will operate, conduct, and manage the nurture of children and youth, help feed and care for families in need in Haiti and the United States, offer training or technical assistance, health and education services, provide job creation as described in section 501(c) (3).

The foregoing purposes and activities shall be interpreted as examples only, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any lawful purpose or purposes not for pecuniary profit and not specifically prohibited to corporations under other laws of this state in furtherance of the organization's exempt purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be stated in the bylaws.

ARTICLE VI EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
