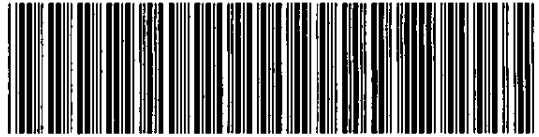

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is established to preserve Miami's music history by creating educational displays of musical events and artist that have empowered Miami to become a Mecca of culturally diverse music. It will also aim to strengthen the musical arts, support emerging artists, and encourage others to enter the music profession by providing scholarships and grants to music arts students and by promoting the benefits of music entertainment to the public.
This company is organized exclusively for charitable, literary, and educational purposes. Including for such purposes, the making of distributions to organizations that qualify under section 501 (c) (3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

No proceeds of the corporation shall enrich any individual except that reasonable compensation may be paid for services to the corporation.
No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in any political campaign on behalf of any candidate for public office.
If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as tax-exempt, charitable organization under the provisions of 501 (c) (3) of the Internal Revenue Code.
